Acres in Northern Arizona

Coleman Dahm & Associates recently completed a survey of registered Arizona voters in order to assess their views on special interests' efforts to lock up 1.7 million acres in Northern Arizona by presidential executive order. **The survey found overwhelming opposition for such action from voters throughout Arizona,** with 71.6 percent saying they oppose such executive action. Strong opposition is prevalent throughout all political parties within the state of Arizona and a strong majority of Republicans, Democrats and Independents in the 4th Congressional District oppose the proposed land grab.¹

Poll Question

The federal, state and tribal governments in Arizona already own 81.8 percent of all Arizona land, leaving just 18.2 percent open to private owners. Do you support the special interests' effort to lock up 1.7 million more acres in Northern Arizona by presidential executive order which could kill jobs, harm tourism, agriculture and water rights, and prevent hunting and fishing?

¹ Methodology: On April 20, 2016, Coleman Dahm & Associates completed 499 telephone interviews (on both landlines and cell phones) with registered Arizona Voters throughout the state of Arizona. The margin of sampling error for the study's statewide and 4th Congressional District results is +/- 5% at the 95% confidence level.
